Minutes

Southeastern Chapter, American Association of Law Libraries Monday, June 14, 1982, Detroit, Michigan

The business meeting of the Southeastern Chapter of the American Association of Law Libraries was called to order by Robin Mills at 8:00 a.m. on Monday, June 14, 1982, at the annual meeting of the American Association of Law Libraries at the Westin Hotel in Detroit, Michigan. The initial order of business was the introduction of officers seated at the head table followed by the customary introduction of all members in attendance.

Ed Edmonds gave the treasurer's report. The beginning balance after transfer of funds to Williamsburg, Virginia, was \$774.15. Deposits included a return of the advance from the Atlanta meeting of \$1,250.00, \$209.00 for the breakfast meeting in Detroit, and \$1,560.00 for 1982-83 dues. The total deposits were \$3,019.00. Debits included \$16.00 for a newsletter insert and \$750.00 for scholar-ships. The ending balance on June 9, 1982 was \$3,027.15.

Bill James gave the Scholarship Committee report. The Scholarship Committee received four applications during the year. Four scholarships were awarded, and three were accepted. Bill was concerned about the significant drop in the number of applications during this year and felt that perhaps more publicity concerning the scholarships was necessary. He thanked the members of the committee for their help during the year. Scholarship recipients Patsy Brautigam and Louise Stafford were acknowledged.

Robin Mills announced that there would be a meeting in Savannah on August 12-14, 1982, with the Southeastern Conference of the Association of American Law Schools. Erwin Surrency will chair a panel on the afternoon of August 13. There will not be a formal business meeting, however, and the next formal business meeting will be at the Orlando meeting in February.

Pat Strougal asked for the support of the Southeastern Chapter for a joint offer with the Atlanta Chapter to the American Association of Law Libraries to host the 1988 meeting in Atlanta. The membership agreed to give strong support to such an offer.

Since there was no other old business, Robin Mills proceeded to the new business. She introduced the new Chapter officers: Donald Ziegenfuss, President, Kay Todd, Vice President-President/Elect, and Ed Edmonds, Secretary/Treasurer. Robin thanked everyone for their support during her two years as President. After an acknowledgement from the membership, Robin proceeded to turn the meeting over to Don Ziegenfuss and presented him with a ceremonial inscribed gavel.

Don Ziegenfuss thanked Robin Mills on behalf of the Chapter for her two years of dedicated work. Don then acknowledged the presence of Leah Chanin, the incoming President of the American Association of Law Libraries, and he asked her to speak to the group. Leah noted the very diverse interests of the membership of the American Association of Law Libraries. She also discussed the recent board action in presenting a refundable grant of \$15,000.00 to the Law Library Association of Greater New York to conduct a union list project. She encouraged members of the Association to present proposals for worthwhile projects to the board. Leah continued by noting her long association with the Southeastern Chapter and stated that she would rely particularly on this Chapter for support during the upcoming year.

Don Ziegenfuss then announced that the next meeting of the Southeastern Chapter would be in Lake Buena Vista, Florida, on February 10-12, 1983. Lake Buena Vista is located near Orlando and Disney World.

Don continued by announcing the committee chairmen for the upcoming year. The Program Committee will be chaired by Kay Todd. The chairman of the Membership Committee will be Christine Johnson. Lamar Woodard will chair the Nominating Committee, and Joseph Cross will head the Placement Committee. The Scholarship Committee will be chaired by Gene Teitelbaum, and Howard Hood will head the Constitution and Bylaws Committee.

Bill Younger noted that it has been customary in the past to present a plaque to the outgoing president. He asked for a voice vote for consent to empower Don Ziegenfuss to perform this duty. That voice vote was given.

The meeting was adjourned.
